MISSION AND BY-LAWS OF THE COUNCIL: Attached to agenda for informational purposes.

RECOMMENDATION TO APPOINT CITIZEN MEMBERS:

ACTION: Motion by Thimm, second Wick, to approve Carolyn Jones and Donna Stone as recommended. Motion carried.

HEROIN DIVERSION GRANT: SPD Chief Alexander summarized the grant which will award 3 pilot programs in the state. Components of the grant application and requirements, if application successful, reviewed. Research and evaluation process would be conducted by UW-Superior.

ACTION: Motion by Thimm, second Fruehauf, to support application for the Wisconsin Department of Justice Pre-booking Diversion Program grant. Motion carried.

GOALS FOR 2018:

Priority #1 – “Warrant Resolution Day”: Parameters, logistics, technology, stakeholders, promotion, work group tasks discussed. Wick and Thimm, familiar with the St. Louis County program, explained the process. Douglas County has about 2200 outstanding warrants.

ACTION: Motion by Thimm, second Fruehauf, to approve work group of Fruehauf, Dollen, Wick, Dalbec and Glonek, to develop Douglas County Warrant Resolution Day. Motion carried.

Priority #2 – 2018-2019 Community Service Work Program (CSWP) for Douglas County:

A program primarily for juvenile cases ended 15 years ago in Douglas County due to funding. It provides judges an option to assign community service as part of sentencing. Statute would need to be researched as to whether community services can be in lieu of any fines. A community group would have to partner to supervise the program.

ACTION: Motion by Fruehauf, second Thimm, to research Community Service Work Programs in other counties and report back to this Council at the July meeting. Stank, Thimm and Fruehauf volunteered for this project. Motion carried.

2018 CJCC SUGGESTED MEETING SCHEDULE: Council agreed with dates of July 12, October 11, December 13; same time. Work groups can ask for special meetings if needed.

ADJOURNMENT: Motion by Thimm, second Fruehauf, to adjourn. Motion carried. Adjourned at 12:40 p.m.
