Meeting called to order by Chair Sam Pomush.

ROLL CALL: Present - Rosemary Lear, Alan Jaques, Peter Clark, Sam Pomush. Absent – Marvin Finendale. APPROVAL OF MINUTES: Motion by Jaques, second Lear, to approve November 30, 2017, meeting minutes. Motion carried.

UPDATES AND REPORTS: Budget reports attached/reviewed for each department. **Child Support** – Budget overrun due to employee health insurance and decrease in revenues. **Circuit Court Branch I and Probate** – GAL / CHIPS attorney numbers increased. **Clerk of Courts** – Attorney fees increased ver last year; tax intercepts are in play; freezing bank accounts may help with collections; 10,000 cases processed in 2017. **Court Commissioner** – Budget overrun due to personnel costs and increase in some fees. **District Attorney** – Began charging Public Defenders and private attorneys for discovery; addition of 20 hour front desk clerk has been very helpful; filed over 100 more misdemeanors and felonies in 2017 over 2016; new Assistant DA Angela Wilson started today; state may add funding for 54 Assistant DA's statewide – Douglas County potentially to receive 2 full-time positions in June/July. **Emergency Management and Communications Center** – Additional \$25,000 redistribution funds received; Miller appointed to state 911 committee and Kesler on radio committee. **Sheriff** – **Patrol Division** – Deputy interviews next week for 3 yacancies; **Jail Division** – Seven of ten yacancies now filled.

ACTION ITEMS/REFERRALS:

Rescind Ordinance #1.23 Fee for Sheriff's Sale: No ordinance required per statute.

ACTION (ORDINANCE): Motion by Lear, second Jaques, to approve rescinding Ordinance #1.23 and forward to County Board. Motion carried unanimously.

Establishing Sheriff's Sale and Civil Process Fees for Sheriff's Department: Attachments reviewed. Committee raised several questions regarding fee structure and actual costs.

ACTION: Motion by Lear, second Jaques, to refer Sheriff's Department fees to March meeting with request for the following information: 1) Consider 2-tiered fee structure for internal and external application, if allowed; 2) Impact on county department budgets if 2-tier not allowed; 3) Cost analysis process for determining actual processing cost; and 4) Current private processor fees. Motion carried.
