Conditional-use permit: Duluth Landfill Superior LLC, et al. (from the March 13, 2019, hearing): Construction and demolition waste landfill – SE1/4-NE1/4-SE1/4 & SE1/4-SE1/4, Section 9, T48N-R14W; (3161S Cemetery Rd; TS-030-01299-00; 01302-00), Town of Superior.

Brett Ballavance present representing applicant; no Town of Superior approval. Applicant has not received DNR and Corps of Engineers exemptions and required associated permits. Responsibility for maintenance of the road discussed in relation to applicant's use, as portions of the road are owned by City of Superior, Village of Superior, and Town of Superior. Major issue is the required 250 ft. setback; cutting a small portion of the southeast corner could address the problem. Otherwise, variance application would go to Board of Adjustment. Continued concerns exist on water navigability, visibility and impact to wetlands. Town of Superior meets tonight.

**ACTION:** Motion by Baker, second Borgeson, to defer action on the conditional-use permit until DNR and Corps of Engineers, permits and exemptions are completed, all requested information is submitted for review, and Town of Superior decision is received. Motion carried.

**Groundwater Program - \$10,000:** Continuation of groundwater programs – well sampling, public education programs, and GIS database project.

Motion carried unanimously.
